Subject:- Irregularities in promotions in respect of Group 'B' & 'C' Non-Gazetted Cadres in
CBEC - regarding.

Sir,

A number of references are being received from citizen and CBEC employee under RTI & CPGRAM enquiry about letters issued by the Board (by Sh. Rajpal Singh, the then US.Ad.III.A&B) relating to promotions in Group 'B' (Non-Gazetted) and Group 'C' posts under CBEC. A number of clarifications have also been received from CCAs under CBEC.

2. The issues of promotion (including notional promotion) from the grade of TA to EA (Erstwhile STA) & EA to Inspector and from the grade of Steno-II to Steno-I & Steno-I to Inspector including clarification issued by the Board are under submission to the Board in different files. Till date no decision has been taken.

3. In the meantime, it has come to notice that some clarifications/letters purportedly issued under the signature of Sh. Rajpal Singh, the then US.Ad.III.A which have not been approved by the competent Authority/Official procedure of issuing has not been adopted. The list of unauthorised letters is given below:-
