**Subject :** Re-organisation of CBEC field formations in GST-regime – merger / creation of DDO for making expenditure – Reg.

Reference is invited to OM No. Coord/2(1)/DDO Codes/2017-18/Vol.X/89 dated 26/07/2017 on the above mentioned subject, whereby the existing DDO system (prior to reorganization of field formations) was allowed to continue for July 2017.

As the process of allotment of new DDO codes, change in the nomenclature of existing DDOs and their mapping with respective PAOs is going to take some more time, therefore, in continuation of the afore-mentioned OM, **the existing DDO system (prior to re-organization of field formations) is allowed to continue further for the salary month of August 2017.** This arrangement is made to ensure smooth payments of Salary and other bills of August 2017.

**It is therefore requested to issue necessary directions to field formations in this regard to facilitate the smooth release of salary & other payments for August, 2017.** PAOs are also directed to accept the Salary and other bills from the DDOs already mapped with them and process it for payment in the manner it was being done prior to re-organization of field formations.
