Sub: Content management of CBEC Website.

The new CBEC website has been launched by the Hon'ble Finance Minister on 24th August, 2015. Although the website has most of the technical and security parameters complied with, the contents appear to be not being managed appropriately by the Content Administrators.

Your kind attention is invited to the letters dated 03.03.2015, 07.05.2015, 09.01.2015, 06.02.2014 and 13.11.2013 requesting *inter-alia* that the list of Contents Administrators (Copy attached) is not updated; the Contents Administrators are not ensuring updated contents and provide contents in Hindi or bilingual form, to the Webmaster.

Since CBEC website contents are provided by the field formations, Directorates and different branches of CBEC, it is responsibility of the Content Administrators to keep track of its update. Further, Rajbhasha Parliamentary Committee has been pressing hard to keep the contents of website bilingual as stipulated under Rajbhasha Adhinyam, 1963 and Rajbhasha Niyam 1976.

You are therefore requested to kindly ensure that the Content Administrators update the contents regularly through webmaster.cbec@icegate.gov.in and the new contents which are required to be uploaded are forwarded in bilingual format. The updated list of the Content Administrators may also be communicated to this office by 15.09.2015.
