Sub: Preparation of panel for appointment of **Senior Intelligence Officer & Intelligence Officer** in the Directorate General of GST Intelligence, **Mumbai Zonal Unit (on deputation basis)** - C/Regarding.

The Directorate General of GST Intelligence, Zonal Unit, Mumbai is in the process of drawing up a panel of suitable candidates for filling up the existing vacancies in the grade of Senior Intelligence Officer & Intelligence Officer at the **DGGSTI, Zonal Unit, Mumbai on deputation basis.**

It is proposed to fill up these vacancies by appointing suitable officers on **deputation basis** from the grade of Superintendent & Inspector of Customs & Central Excise for the post of Senior Intelligence Officer & Intelligence Officer respectively.

The deputation period is for a five years. It may also be pertinent to mention that the option for deputation basis in DGGSTI once exercised cannot be withdrawn under any circumstances.

It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officer, the following information in respect of them may also be sent for evaluation by this Directorate General:-

1. Complete Bio-data and willingness of the officer alongwith history of previous postings;
2. List of cases booked on his own Information/Intelligence alongwith duty involved and recovered.
3. APAR grading for the last 5 years including the year 2016-17 {Duly verified and attested by the Addl./Joint Commissioner (P&V)};
4. Vigilance Clearance; and
5. No-objection from Cadre Controlling Authority to relieve the officer in the event of his selection.
