- Notification No.23/2017-Customs, dated 12.06.2017 has been issued to Seeks to amend Notification No. 12/2012-Customs dated 17<sup>th</sup> March, 2012 to insert entry no. 333F in the table after entry no. 333E.
- Notification No. 27/2017-Customs(ADD), dated 12.06.2017 has been issued to impose provisional ADD on the imports of "ceramic tableware and kitchenware, excluding knives and toilet items", originating in or exported from China PR for a period not exceeding six months(unless revoked, amended or superseded earlier) from the date of publication of this notification in the Gazette of India.

- Notification No. 28/2017-Customs(ADD), dated 14.06.2017 has been issued to impose ADD on the imports of "Hydrogen Peroxide" originating in or exported from Bangladesh, Taiwan, Korea RP, Pakistan and Thailand for a period of five years.
- Notification No. 29/2017-Customs(ADD), dated 14.06.2017 has been issued to impose antidumping duty on "Soluble Salt Double Charge, GVT and PGVT, Porcelain/ Vitrified Tiles with less than 3% water absorption and All sizes"originating in or exported from the China PR for a period of five years (unless revoked, amended or superseded earlier) from the date of imposition of the provisional anti-dumping duty, that is, the 29th March,2016, imposed vide Notification number 12/2016 dated the 29th March, 2016.
- Notification No. 30/2017-Customs(ADD), dated 16.06.2017 has been issued to (a) impose antidumping duty on "Clear Float Glass of nominal thickness ranging from 4mm to 12 mm (both inclusive produced and exported by M/s Tariq Glass Industries Ltd, Pakistan, originating in or exported from the Pakistan. (b)seeks to rescind the Notification No. 53/2015-Customs (ADD), dated the 30th October, 2015
- Notification No. 15/2017-CENT, dated 12.06.2017 has been issued to amend Cenvat Credit Rules, 2004 to allow un-availed CENVAT Credit in respect of services provided by the Government, local authority or any other person by way of assignment of the right to use of any natural resource.
