Based on the inputs received from various sections, following is the compilation of the important developments for the week –24.07.17 to 28.07.17.

1. Administrative Changes:-

- Order regarding placement of services of Shri Harsh Singh, IRS with department of revenue consequent upon his appointment to the post of Technical Officer(TRU) in CBEC has been issued vide Office Order No. 127/2017 dated 24.07.2017.
- Order regarding antedating the promotion of Shri Ramesh Kumar in the grade of Assistant Commissioner of Customs and Central Excise purely on ad-hoc basis, notionally w.e.f. 22.10.2014 has been issued vide Office Order No. 128/2017 dated 24.07.2017.
- Order regarding posting of Shri S. Mahesh Kumar, Assistant Commissioner of Customs and Central Excise with GST Council on loan basis has been issued vide Office Order No. 129/2017 dated 26.07.2017.
- Order regarding extension of loan period upto 31.10.2017 in respect of Shri Aman Garg, IRS presently working as OSD in Judicial Wing of CBEC has been issued vide Office Order No. 130/2017.

- Notification No. 68/2017-Customs, dated 27.07.2017 has been issued to amend Notification No. 96/2008-Customs dated 13.08.2008 to insert S.No. 35 – Republic of Niger and S. No. 36 – Republic of Guinea in the Schedule to the notification.
- Notification No. 36/2017-Cus (ADD), dated 28.07.2017 has been issued to continue anti-dumping inforce concerning imports of 'polytetraflouroethylene or PTFE' originating in exported from China PR.

- Circular No. 31/2017-Cus-IV(N.T.) dated 25.07.2017 issued for extending the Single Window Interface for facilitation of Trade (SWSIFT) in Exports with WCCB to all EDI locations-reg.
