**NOTICE INVITING E-TENDER FOR HIRING OF OFFICE PREMISES AT  
CHANDIGARH ON RENT FOR AN INITIAL PERIOD OF THREE YEARS**

1. Online e-tenders are invited for and on behalf of the President of India by the Additional Director General, DGGSTI, Chandigarh for hiring an office building at Chandigarh on monthly rent basis and measuring in the range of 8,000-9,000 sq. ft initially for a period of three years.
