

TERMS AND CONDITIONS

- 1) NACIN, Bangalore situated at No.40, HMT Factory Main Road, next to HMT School, Jalahalli, Bangalore is a premier training academy under the Central Board of Customs, Indirect taxes and narcotics and is involved in training Gr. A officers of Indian Revenue Service apart from the officers of the Central Taxes, Karnataka Zone. Yoga and other physical activities form a part of the training courses in the academy.
- 2) NACIN, Bangalore desires to outsource the services of one Yoga instructor and one instructor for physical activities viz: swimming/ use of gym equipments /indoor sports activities on need basis for trainees.
- 3) Reputed agencies/institutions or individuals may submit their bid for the above work. The bidder should have adequate experience in his field and should be well versed in his field of training and also be in possession of a certificate from a reputed university/institute in the concerned subject. The agency/individual bidders shall enclose copies of the certificate and other details of the trainers he plans to deploy along with their bio-data and supporting documents indicative of their experience.
- 4) The sessions on yoga and physical activities will be held at NACIN as per the schedule given under:

SCHEDULE FOR YOGA

Morning 6.30 A.M to 7.45 A.M (Monday, Wednesday and Friday)

Evening: 2.45 P.M to 4 P.M (Tuesday and Thursday)


SCHEDULE FOR PHYSICAL ACTIVITIES

Swimming: 2.45 P.M to 6.00 P.M (Monday to Friday)

Gym activities & Indoor Sports activities: 6.30 A.M to 7.45 A.M (Tuesday and Thursday)

- 5) NACIN will provide all the equipments required for the various activities mentioned above. The identified bidders will impart training to the trainees in a batch which will consist of a minimum of 35-40 officers.
- 6) In the financial bid, the bidder should indicate the rates/hour for providing of a yoga trainer and a physical activities trainer. The rate so quoted should be inclusive of all factors and shall be valid for a period of one year. No revision of rates will be applicable during the period of contract entered into.
- 7) The bidder shall follow all the statutory rules and regulations governing such contracts and NACIN cannot be held liable for violation of any such Laws/Rules in force.

- 8) NACIN desires to outsource these services on need basis. The services of the identified instructors will not be utilized on days when the trainees are not in the campus.
- 9) Final selection of the instructors will be made by a nominated team of officers of NACIN after a demonstration session and checking of all other credentials of the deployed personnel.
- 10) In case the deployed personnel for any of the activities cited herein are unable to attend on a particular day, the bidder shall intimate the officer in charge of the course well in advance and also make alternate arrangements so as to ensure that the course schedules are not hampered.
- 11) Additional Director General, NACIN reserves the right to reject any or all the bids received without assigning any reasons.
