1. Only reputed parties with sufficient technical expertise will be considered.
2. The sealed quotations may be submitted till **01/08/2008** upto **05.00 PM** in the office of the Assistant Commissioner of Customs, EDI, Custom House, Cochin -9.
3. The sealed quotations will be opened on **04/08/2008** at **11.30 AM** in the office of the Systems Manager, Custom House, Cochin 9.
4. The Systems Manager reserves the right to accept/reject any or all quotations without assigning any reason.
5. If the services under this contract are not rendered properly/satisfactorily and/or in a time bound manner as may be decided by the Custom Authorities, the charges borne by the Customs Department for getting the services rendered by other means will be deductible/ recoverable from the bidder to whom this contract is awarded.
9. In case the selected bidder wishes to discontinue the said AMC at any point of time, after acceptance, a notice to this effect should be given to this office at least three months in advance. The Department is however, at liberty to terminate the contract with immediate effect in case of breach of any of the terms and conditions of the said contract or if the services are not found to be satisfactory.
10. Prices quoted shall be inclusive of all taxes of any government/local authority etc. as applicable to government department. No payment over and above the prices quoted shall be done by the Customs in respect of any such levies brought to the notice at a later date.
11. The date of commencement of maintenance will be considered from the final date of installation of the redesigned website.

12. The uploading of the redesigned website will be subject to security audit specified by the NIC before hosting to the Government site. The selected bidder will be responsible to get clearance from the NIC.

13. Within 15 days after the receipt of intimation of award of the Contract from the Principal, the successful bidder shall enter into a Contract in the prescribed form.

14. The Custom House is not responsible for non-receipt/late receipt/loss of the tender documents due to postal delay.
