**OFFICE ORDER NO. 264 /2010**

The President is pleased to promote the officers mentioned in **Annexure-I, II & III** from the grade of Customs Appraisers to the grade of Assistant Commissioner of Customs & Central Excise in the Pay Band 3 with Grade Pay of Rs 5400/- on purely *ad-hoc* basis, notionally w.e.f 10.09.2008, 16.10.2009 and 27.10.2010 respectively. The appointment is for a period of six months or until further orders, whichever is earlier.

2. In view of the seniority list of Customs Appraisers being in dispute in various Courts ; and in compliance with the Orders dated 29.09.2010 of the Hon'ble CAT Mumbai Bench in OA No.686/2010 in particular, the promotion of the officers listed in the Annexures-I, II & III hereto shall be provisional and subject to the final outcome of the O.A. No.686/2010 as well as the other related Court cases, which should be specifically noted by these officers being promoted.

3. The promotions of the officers at Sl. No.9, 10 and 42 of Annexure-I shall be effective from the date of completion of their respective penalty periods.

4. The promotion to the grade of Assistant Commissioner of Customs and Central Excise is purely on *ad-hoc* basis for a limited period of six months only and does not confer any right on the officers so promoted for any claim for continued officiation or regular promotion in the grade and the period of such service will not count for seniority or as qualifying service for further promotions.

5. The *ad-hoc* promotions of the officers mentioned in Annexures-I,II & III shall be initially on **in-situ** basis. The formal posting/ transfer orders will be issued separately.

6. The Commissioners concerned shall ensure that if any of the officers, whose name has figured in Annexures-I, II & III to this order, is under suspension or facing any charge sheet or prosecution, he/ she should not be allowed to assume charge in the grade of Assistant Commissioner and this fact should be reported to the Board immediately.
