Sub : Preparation of a panel for filling up post of Technical Officer (T.O.) Group- B (Non-Gazetted) on deputation basis in the Directorate General of Human Resource Development (Infrastructure & Welfare) – Regarding.

It is proposed to draw a panel of suitable and eligible officers for filling up the deputation post in the grade of Technical Officer (T.O.) Group 'B'(Non-Gazetted) in the Directorate General of Human Resource Development (Infrastructure & Welfare Division) at New Delhi on deputation basis. The post are in the pay Band -2 of Rs. 9300-34800/- with grade pay of Rs.4600/-.

2. In accordance with the recruitment rules applicable to the post, the officials holding the following posts on regular basis are eligible to be considered for appointment against the deputation post of Technical Officer (T.O.) Group 'B'(Non-Gazetted) in the Directorate.

- (i) Inspectors of Central Excise
- (ii) Preventive Officers of Customs and
- (iii) Examiners of Customs

3. The officials selected for posting as Technical Officer (T.O.) Group 'B'(Non-Gazetted) in this Directorate on deputation basis would be appointed initially for a period of 3 years. The pay of the selected officer will be regulated in accordance with the Ministry of Finance O.M. No.19(24)E III/60 dated 04.05.1991 as amended from time to time. Presently, the Technical Officers (T.O.) are entitled to Deputation (Duty) Allowance in terms of DOPT's O.M. No.2/22(A)/2008-Estt (Pay-II) dated 03.09.2008.

4. Applications from interested and eligible officers accompanied by relevant personal data viz. name, date of birth, educational qualification, knowledge of operating computers if any, present post and the date from which it is held, scale of pay, history of previous postings along with charges held accompanied by their CCR dossiers may please be forwarded to this Directorate latest by 15th September, 2010. It may also please be certified that no vigilance/non-vigilance case is pending or being contemplated against any such officers. Preference will be given to officers who have knowledge of computer applications. Officers applying for the post may be clearly made to understand that if they apply for the post, they will not be allowed to withdraw their candidature subsequently.
