Subject : Preparation of panel for appointment as Intelligence Officer on deputation in the Directorate of Revenue Intelligence, Delhi Zonal Unit at New Delhi, Regional /Sub-Units at Ludhiana, Jaipur, Jammu, Amritsar and Srinagar in the pay scale of Rs.9300-34800/- (Revised Pay Band) plus Rs.4600/4800 (Grade Pay)- reg.

The Directorate of Revenue Intelligence, Delhi Zonal Unit is in the process of drawing a panel of suitable candidates for filling up the vacancies at Delhi Zonal Unit , New Delhi and Regional Units at Ludhiana, Jaipur & Jammu as well as Sub-Regional Unit at Srinagar/Amritsar/Jodhpur in the grade of Intelligence Officer in the pay scale of Rs.9300-34800 {Pay Band plus Rs.4600/4800 (Grade Pay)}.

2. It is proposed to fill up the vacancies by appointing suitable officers on deputation basis with a minimum of three years of service in the grade of Inspectors who have been granted financial upgradation under ACP Scheme, are also eligible for the said post.

3. The selected officers, while working in the Directorate in the grade of Intelligence Officer, will be entitled for a special pay of 10% of the basic pay as defined in FR 9(21)(a)(I) in the revised pay scale subject to the prescribed ceiling of Rs.1600/- per month. Normally, the deputation is for a period of five years which is extenable by another two years, subject to the willingness of the officers, his/her performance, and the concurrence of his parent department.

4. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the applications of willing officers forwarded to this office. While forwarding the names of willing officers, the following information in respect of them may also be sent for evaluation by this Directorate:

- (i) Bio-data and willingness of the officer alongwith history of previous posting.
- (ii) No objection Certificate from Chief Commissioner to relieve in the event of his selection.
- (iii) ACR grading for the last 5 years including 2009-10 duly verified and attested.
- (iv) Vigilance Clearance Certificate.
